COR-A-VENT LIMITED WARRANTY

- 1. LIMITED WARRANTY: Cor-A-Vent Ridge and Soffit Vents are warranted to the original consumer-purchaser, subject to the conditions set forth in this limited warranty, under normal use and service, and when installed in accordance with the manufacturer's published instructions, to be free of manufacturing defects in material and workmanship which could impair the useful life of the vent, for the lifetime of the roof on which it is installed.
- 2. REMEDIES: During the period of this limited warranty, when it has been determined by the manufacturer that there is a defect covered under the conditions of this limited warranty, Cor-A-Vent Incorporated will repair or replace the Ridge and or Soffit Vent without charge to the original consumer-purchaser, however Cor-A-Vent's maximum liability will not exceed the original purchase price of the Cor-A-Vent Ridge and or Soffit Vent.

At the option of Cor-A-Vent Incorporated, when it is not possible or economically feasible to repair or replace the Ridge and or Soffit Vent as described above, Cor-A-Vent Incorporated will refund the original purchase price to the consumer-purchaser. Monetary settlement as described above will be the only remedy available under the terms of this limited warranty.

3. LIMITED LIABILITY: The obligations and liabilities of Cor-A-Vent Incorporated under this limited warranty or under any implied warranty, do not include any responsibility for damages whether general or specific, direct or indirect, consequential, incidental, exemplary or otherwise, except as described herein.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply.

- 4. LIMITATIONS ON COVERAGE: Cor-A-Vent Incorporated will not be liable for, and this limited warranty does not apply to:
 - a. failure, defect, damage, or loss resulting when the Cor-A-Vent Ridge and or Soffit Vents are not installed properly in accordance with the manufacturer's printed instructions.
 - b. damages due to causes beyond normal use and service including, but not limited to:
 - 1. Fire, flood, hail, lightning, windstorm, acts of God, or any natural disaster.
 - 2. Improper storage or handling of Ridge and or Soffit Vent.
 - 3. Alteration, unreasonable use, accident or negligence.
 - 4. Any cause other than manufacturing defects.
 - 5. Labor costs incurred except as provided for herein.
 - 6. Claims by subsequent owners or transferees. This warranty is personal to the original consumer-purchaser and is not assignable or transferable under any circumstance.
 - Any damage due to the interior or to the exterior of any building or to any property
 contained therein, or for any injuries or damages sustained by any person, or consequential or special
 damages of any kind whatsoever.
- 5. NOTIFICATION OF CLAIMS: All claims for remedy under this limited warranty must be submitted in writing, together with proof of purchase, installation date, and an explanation of the alleged defect, within thirty (30) days of discovery and sent by certified mail, to: Cor-A-Vent, Inc., P.O. BOX 428, Mishawaka, IN 46546-0428

Cor-A-Vent Incorporated reserves the right of inspection of the Ridge and or Soffit Vent by an authorized representative prior to the settlement of any claim and the consumer-purchaser must allow reasonable investigation of the claim.

6. SOLE WARRANTY: This limited warranty is exclusive and replaces all other warranties whether express or implied and may not be changed or modified. Any implied warranty including any implied warranty of merchantability or fitness for a particular purpose, shall be limited to the terms and conditions of the expressed warranty set forth herein.

No representative, employee or agent of Cor-A-Vent Incorporated, or any other person has the right to assume for Cor-A-Vent, Incorporated any additional liability or responsibility for damages as described above.

This limited warranty gives you specific legal rights and you may have other rights, which vary, from state to state.
